Retailers can be part of the Queensland Government's Battery Booster Program by supplying householders with quotes for Approved Battery Systems. So long as householders meet the eligibility requirements, these quotes are valid and can be used for conditional approval for participation in the program.

Retailers are encouraged to include the details of their subcontracted Approved Installer in any quotes to customers seeking a Battery Booster rebate.

Rebates of up to \$4,000 are now available for eligible Queenslanders to purchase and install household battery systems connected to new or existing rooftop solar photovoltaic (PV) systems.

A \$3,000 rebate is available to eligible applicants with a combined annual household taxable income of \$180,000 or less, and a higher \$4,000 rebate is available for low-income households with an annual income of less than \$66,667.

Householders will need to get conditional approval using their retailer quote before applying for a rebate. Householders must then use an Approved Installer to install the Approved Battery System.

Eligibility

Householders will need to meet the following eligibility criteria:



Income: have a combined annual household taxable income of \$180,000 or less for the standard rebate, or an applicant annual income of less than \$66,667 for the low-income rebate.



Ownership: own the premises where the new battery is to be installed.



Battery: buy a battery from the Queensland Government's list of Approved Battery Systems with a minimum 6 kilowatt hours (kWh).



Solar photovoltaic (PV) system: be connected to a minimum 5 kilowatt (kW) solar PV system (new or existing).



Installation: use a Queensland Government Approved Installer to install the Approved Battery System.

Application process

Visit qld.gov.au/battery-booster-program to check you're eligible for the rebate, then complete the following steps.

Application



STEP 1 – Select an Approved Installer **or another retailer** and get a quote for your new Approved Battery System*. You are encouraged to seek multiple quotes and do your own research and comparisons before making a significant purchase decision.



STEP 2 – visit the QRIDA application portal to apply for conditional approval to confirm if you are eligible for a rebate.* You cannot apply for the rebate until you have received a conditional approval letter. Batteries installed before conditional approval will not be eligible.

Installation



STEP 3 – Within 90 days of receiving your conditional approval letter, have your Approved Battery System installed by an Approved Installer. On the day of installation, you should double-check that your installer is on the current Approved Installer list otherwise you won't be able to claim the rebate.

Rebate



STEP 4 – Pay the full invoice amount for the purchase and installation of your Approved Battery System.



STEP 5 – Using the QRIDA application portal, apply for your Battery Booster rebate.



STEP 6 – Once you have submitted your application with all the required documentation, you will receive a rebate notification letter, normally within a few weeks, about the outcome of your application.



STEP 7 – If your rebate application is successful, you will receive payment into your nominated bank account within approximately three business days of receiving your rebate notification letter.

Safety and compliance inspections

Battery systems installed under this program may be inspected by an independent inspectorate appointed by the department.
